

**GLOUCESTERSHIRE COUNTY COUNCIL**  
**TEMPORARY TRAFFIC ORDER**  
**C74 HIGH STREET (TWYNING PARISH)**  
**(TEWKESBURY BOROUGH) ORDER 2018**

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for C74 High Street ("the Road") is satisfied that use of part of the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road from its junction with Church End Lane to its junction with Hill End Road for a distance of approximately 170 metres;
2. Nothing in Article 1 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road;
3. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road;
4. The Road falls in Twyning Parish in the Tewkesbury Borough and in the County of Gloucestershire;
5. This Order shall come into operation on the 9th day of July Two Thousand and Eighteen and shall continue in force for a period not exceeding eighteen months;
6. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order C74 High Street (Twyning Parish) (Tewkesbury Borough) Order 2018".

**TEMPORARY CLOSURE OF C74 HIGH STREET, (TWYNING PARISH) TEWKESBURY BOROUGH**

Gloucestershire County Council have made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the C74 High Street, from its junction with Church End Lane to its junction with Hill End Road for a distance of approximately 170 metres.

The reason for the closure is to install a new sewer connection.

The road is expected to be closed from 9<sup>th</sup> July 2018 until 10<sup>th</sup> July 2018 however, it will be closed to HGV's from 9<sup>th</sup> July 2018 until 25<sup>th</sup> August 2018 or until the works have been completed.
